NARRATIVE

On 08/07/2016 at about 0830 hours, I was dispatched to contact [REDACTED] who was at a camp site named Swales Camp which was located at approximately 39.440987N, -123.690240W.

Dispatch transferred [REDACTED] to my phone and he told me the following in summary:

[REDACTED] and his family were staying at the "Swales Camp" since 07/31/2016 and had been doing some reconstruction of the camp. [REDACTED] brought various tools to the campsite and other equipment to use for the reconstruction. [REDACTED] said that the camp site was located about 10 miles east of Fort Bragg next to the skunk train road rails.

Today (08/07/2016) at about 0630 hours, [REDACTED] heard some noises coming from the living room and outside the cabin but did not think it was suspicious because he thought it was family members walking around.

At about 0800 hours, [REDACTED] was approached by his daughter, [REDACTED] who told him that she had seen three suspects walking away from the campsite. [REDACTED] also mentioned that one of the subjects had what appeared to be long rifle slang on his shoulder and another subject was carrying an axe.

The suspects were described as the following:

White male adult about six foot tall and wearing a gray hoodie sweater.

White male adult about six foot tall and wearing a dark jacket.

White female subject about five and a half foot tall, wearing a pink or red jacket.

After [REDACTED] was informed by [REDACTED] of this information, he went and looked around the campsite and discovered that various tools and other items were missing from various locations at the campsite.

[REDACTED] stated that there was a shed about 100 yards near the campsite where he had kept most of the property that had been taken. [REDACTED] also stated that some property was taken from outside the main cabin. [REDACTED] stated that an electric lantern and a

bottle of prescription of pills that were prescribed to his sister, [REDACTED] were taken from the main cabins living room, while [REDACTED] and his wife slept in the master bedroom. [REDACTED] informed me that the doors to the cabin were not locked and that he had not given permission to anyone to take the property out of the camp site.

[REDACTED] informed me that he had to walk to a neighboring camp site (Bowel Camp) to call Mendocino County Sheriff's Dispatch.

Deputy Julian, Deputy K. Comer and I were en-route to the campsite when [REDACTED] contacted me via telephone and told me that [REDACTED] ([REDACTED]'s husband) and him were walking back to check on their vehicles that were parked at the "Holmes Camp" which is located east of their camp site. As they were walking to the Holmes Camp they saw a white Infinity sedan with a California license plate of 7JPS281. [REDACTED] said that there was a male in the back seat who appeared to be sleeping.

Marshall obtained a picture of the male that was sleeping in the back of the vehicle and also a picture of the vehicles license plate.

[REDACTED] said that as he was examining the vehicle when a female subject (S1) and a male subject (S2) walked to the parked vehicle carrying two red gas cans. [REDACTED] asked what S1 and S2 were doing and S2 told him that their vehicle had ran out of gasoline so they had left it there and walked to nearby camp to get gasoline for the vehicle.

[REDACTED] described S1 as a white female adult wearing a red or pink hoodie sweater and had blonde hair and S2 as a white male adult orange jacket and blue jeans.

Dispatch confirmed that the vehicle (CA# 7JPS281) belonged to Antonio Cerezo Flores who lived at [REDACTED] Fort Bragg.

[REDACTED] said that after speaking to S1 and S2 he saw what appeared like a barrel of a rifle under S2's clothing. [REDACTED] decided he did not want to ask questions to S1 and S2 regarding his missing property.

[REDACTED], [REDACTED] and [REDACTED] continued to walk to "Holmes Camp" to check on their

vehicles when they came in contact with [REDACTED] who was staying at that campsite.

[REDACTED] told [REDACTED] that they had seen two unknown male subjects near their camp at about 0530 hours. [REDACTED] and her boyfriend confronted the subjects and asked them what they were doing. One of the subjects stated that their vehicle had ran out of gasoline. Both subjects then walked away.

[REDACTED] told [REDACTED] that she had recognized one of the subjects as a person she went to Fort Bragg High School with the name "Renni"

[REDACTED], [REDACTED] and [REDACTED] checked on their vehicles and observed that they had not been tempered with.

At this time I was re-routed to a physical domestic violence case MCSO 2016-24106.

I contacted [REDACTED] after I completed the domestic violence incident and informed him that I would be investigation the theft. I provided [REDACTED] with my work email so he could email me a list of the property taken.

[REDACTED] emailed me a list of the property that had been taken from the camp site which I documented on this report. I scanned and attached the list to this report. [REDACTED] was unable to provide serial numbers and description for some of the property.

On 08/07/2016 at about 1524 hours, Deputy K. Comer was doing patrol near Road 300 at Kass Road when he made contact with [REDACTED]. [REDACTED] provided K.Comer with her information so I could contact her to obtain further information.

I later asked other deputies in the office if they knew anyone with the name of "Renni" and Deputy Julian informed me that he had made contact with a Christopher Rennacker who is also known as "Renni" in the past. I searched for Christopher Rennacker in the Aegis Mobile system and observed that he had an address of [REDACTED] Fort Bragg.

I also shared the picture of the subject inside the vehicle that was obtained by [REDACTED] to

the other deputies and Deputy Lima stated that the subject in the picture looked similar to a subject names Broderek Todd Klee. I looked up Klee in the Aegis Mobile system and observed that he has and address of [REDACTED] Fort Bragg. I looked at his previous law enforcement contacts with Klee and observed that he has had multiple contacts. In some of the contacts Klee had been a suspect in three or four theft cases.

Recommendation: Follow up with photo line ups of possible suspects.

[REDACTED] and Smith also made an agreement that she would not receive the pink slip until it was paid off completely.

[REDACTED] told me that he works at the Sherwood Oak Health Center with Smith. [REDACTED] said that Smith would be working later today at about 1500 hours.

Later that day at about 1515 hours, I arrived at the Sherwood Oak Health Center which is located at 130 Dana Street, Fort Bragg. I contacted Smith regarding this case, who told me the following in summary:

Smith had been living with Christopher Rennacker at [REDACTED] Fort Bragg for about a week.

Smith said that about 5 days ago early in the morning, her and Rennacker drove towards Company Ranch Road in the white Infinity sedan which she bought from Flores, with Smith being the driver. Smith was unable to provide times or exact dates. Smith said that the vehicle ran out of gasoline at some point during the drive. Smith was unable to say exactly where the vehicle ran out of gasoline but stated that there was rail road tracks nearby.

Smith and Rennacker started walking around various different camps looking for gasoline. Smith said that Rennacker found a friend that lived in one of the campsites where he was able to obtain gasoline. Smith was unable to provide a name for the

friend that gave Rennacker the gasoline.

Smith and Rennacker walked back to the vehicle where they found a white male adult (unknown to Smith) in the back seat of the car. Smith said that she had left her vehicle unlocked. Smith said that she then found out that Rennacker knew the subject and they agreed to give him a ride back to Sherwood Road.

Smith also said that when they arrived to the vehicle they were approached by an unknown man who told them that his cabin had been burglarized. Smith told the unknown man that she did not know anything.

Smith put the gasoline in her vehicle and they drove back towards Sherwood Road where she ultimately dropped off the unknown male subject.

Smith said that she and Rennacker arrived back to her home at about 1500 hours that day.

MCSO Dispatch did a check on Smith for warrants, probation and driver's license status. Dispatch informed that Smith had a non-extraditable warrant out another state and also that her driver's license was expired.
